## 2020 EXOTIC BIRD SALES

**SPRING - SATURDAY MAY 2<sup>ND</sup>, 2020 10:30 am**

**FALL - SATURDAY OCTOBER 3<sup>RD</sup>, 2020 10:30 am**

*(PRE-BOOKING CUT OFF DATE IS THURSDAY PRIOR TO EACH SALE DATE)*

### Auction rules for consignors and buyers:

- All consignors should pre-book their stock – consignments on sale day will sell after pre-booked stock.
- All Pot-Bellied Pigs must be crated. Regular pigs under 40lbs must also be crated.
- Crates and counts not within rules and guidelines will be sold with outside items.
- Maximum weight per lot to be less than 40 lbs per lot. Large heavy crates exceeding 40lbs will be sold outside.
- All birds and animals must be healthy or they will be rejected. Any box arriving at auction ring with expired stock in it will be rejected.
- All birds and animals will be sold in crates, cages or boxes and must be large enough for contents to stand, lay or sit down comfortably. Bedding is mandatory. No re-crating after they are sold. No sacks with animals allowed.
- All boxes must be of adequate size with viewing windows and must be large enough to clearly view contents.  
***(Boxes without viewing windows will not be accepted). \*\*\*\*(Label boxes properly).***
- Wire cages must have a plywood bottom.
- All rabbits, large ducks, geese and turkeys must have plywood bottoms in box.
- Any bird less than two (2) months must be minimum of 10 per box to keep warm.
- All other birds should be pairs, trios or straight females - maximum of 5 per box.
- Multiple males and females that appear to be purebred will be accepted.
  - With the exception of Pigeons and Quail no limit on head count-box not to exceed 40lbs. ***(No overcrowding).***
- Extra Roosters, Crossbred Chickens and Rabbits can be boxed up to 40lbs per box with no limit on head count but must be comfortable.
- Deliberate misrepresentation of consignor stock will be prohibited from participating in future sales.
- Permits required are the responsibility of buyers and sellers and must be in place ***prior*** to buying or selling migratory birds.
- Premise ID numbers must be on consignment form.
- Commission per box is 25% on the first \$100.00 and 15% on balance with a minimum charge of \$6.00 per box.
- Boxes are sold so much per animal/bird times the number in the box.
- G.S.T. applicable on all items.
- Disputes - if a box is required to be resold due to any dispute the seller will be paid the final selling price.
- Methods of payment accepted are CASH, DEBIT, VISA and MASTERCARD. ***(NO CHEQUES)***

- ***All buyers should be at the sale early to inspect boxes or lots they wish to purchase.***

**SALE DAY RECEIVING 7:00 am to 10:00 am on sale day only. Pre-Booked lots arriving after 10:00am will sell in order received.**
